1. All entries are to be home brewed, no commercial entries.
2. Entries are to be two (2) genuine beer bottles (one for judging and one for display)
3. All bottles need to be clearly labelled as to the type of liquor and have the exhibitor's number and name securely attached with a rubber band.
4. Exhibit cards must be presented to claim prizes.
5. All exhibitors enter at their own risk. All care will be taken in the transit, storing, handling and displaying of the entries. Unfortunately, accidents may and do sometimes occur resulting in damage or loss.
6. The Murray Bridge A&H Society Inc. staff, convenors, stewards, committee, judges and volunteers will not be held responsible or liable for any loss or damage to any entry which may occur.
7. The Section judges, convenors, committees or Murray Bridge A&H Society Inc. officials have the right to add, delete, combine or alter any of the advertised classes if they feel it is to be benefit of the Section.
8. The judge's decisions are final. NO correspondence or protest will be entered into regarding the result.
9. The advertising of any items for sale or the displaying of business cards or other advertising material within the Ken Wells OAM Pavilion is strictly prohibited by law.
10. The sale of goods at the show is available to those who purchase a trade site.
11. Following the close of the show on Saturday 28th September 2024 ALL entries and any prizes won MUST BE collected from the Ken Wells OAM Pavilion via the section convenor between 4pm and 5pm.
12. Exhibit Cards and signatures will be required for the collection of entries and any prizes won.
13. Any uncollected entries and prizes will be held in trust by the society and must be collected from the show office by appointment no later than 4th October 2024. All uncollected entries will be disposed of, and any prizes will be recycled after this date.
